# **Curriculum Vitae**

(Ernest Kofele Martin)

I was born in Victoria, Cameroon, on 27<sup>th</sup> January 1906 by the marriage of the late Samuel Luma Martin and late Catherine Muindo. My father, the son of George Luma Martin was born in Victoria in 1875. His father was the son of Luma l'Esingila la Wende of Wovea (Bota Island) and his mother was Drucilla Lisua la Bille, a daughter of Billa Losenge (King William) of Bona Billa, Bimbia, Cameroon.

My mother, Muindo was a daughter of Kofele Njuma Ngombe, a grandson of Billa Losenge (King William) of Bimbia

My wife, Hannah Nene is the daughter of the late Charles Nako Steane, a son of Nako Makangai of Bona-Ngombe, Bimbia by his marriage to Djara, a Fulani lady from Garua, Cameroon.

## 2. Education

a. I attended the Victoria Government School Primary and Secondary Departments from 1917 through to September 1926

b. While undergoing my Pupil Teacher Service from March 1923 through December 1924, I took courses in Secondary school subjects until I became a full time student in the school. At the end of the fourth year, while a British Guianan, Mr. Ben Liverpool was the Principal of the secondary department of Victoria Government School, I became one of the first students of the then Normal College that was started in Victoria in October 1926, and subsequently transferred to Buea in 1927.

I was a student of the University of London, Institute of Education from October 1947 through June 1949 (completing my thesis for diploma in November 1949)

## 3. Certification

- Visiting Teacher with the function of travelling to all the Primary (Government, Local Authority and Mission) schools throughout the then Cameroon Provinces assisting and giving demonstration lessons to all
- Supervisor of Schools with the function of assisting the Provincial Education Officer in the inspection and administration of schools in the then Cameroon Province
- 4. During the period of World War 2 (1940 ..) I was shouldered with the responsibility of the entire administration of the Education Department in the Province whose headquarters were in Buea since there was a shortage of British Officers as they were recruited into the war services.

- 6. Principal of the Government Teachers College, Kumba

Service with the Baptist Mission and the Cameroon Baptist Convention – throughout 1961 up to and including June 1962, I served as a tutor at the Baptist Teachers Training College, Great Soppo, Buea. From July 1962 to August 1971, I served as the Education Secretary of the above agencies.
